Location: Boulder County Fairgrounds, Bldg A, 9595 Nelson Rd. Longmont, CO.

Eligibility: Open to all current members of the Boulder Art Association and Longmont Artists' Guild

Entry Rules: All mediums, including 3-dimensional work will be accepted. Art must be original and not copied from a published photo or creations of other artists. Painting giclees are acceptable as bin work only. All shrink wrapped art will be considered as bin work only. All 2D entries need to have finished edges and must be ready to hang with wire (no saw tooth hangers) and with identification on the back: artist name, title, category and price. Sculptors may provide their own bases or prearrange to have them provided. All unsold art must remain in the show until June 10, 4:00 pm and we must be vacated by 5:00 pm. Storage is not available. All submitting artists are required to work the show for one 2 hour period. The committee reserves the right to reject inappropriate subject matter or artwork that is not suitably displayed.

Limitations: 3 pieces of framed artwork and unlimited bin work with protective wrapping including cards may be entered. Small pieces of framed artwork (14" and under) can be considered as bin work. *There will be no size limitation on entries but if your entry is 24'x36' and over provide an easel for displaying the piece.* All items must be clearly identified with artist's name, price and an inventory number. Please submit an itemized bin work sheet with every item listed on the sheet. Drop off sheet and art work on art delivery date.

Categories: Oil, Watercolor, Acrylic, Pastel, Drawing and Print Making (ink, pencil and colored pencil), Standard Photography, Digitally Enhanced Photography, Sculpture, Mixed Media, and Fiber Art (no kits, original artwork)

Awards: Judge Lorenzo Chavez will award ribbons and cash in all the categories.

Judge: Lorenzo Chavez-graduated with honors from the Colorado Institute of Art in 1983. He is a distinguished workshop instructor of pastel landscapes. Lorenzo's work is represented in five galleries in the United States and is included in many private and corporate collections both nationally and internationally.

Sales: All artwork must be for sale. A 25% commission will be charged on all work sold. Price of delivered artwork must match the price on the entry form. An artist may replace a sold item.

Liability: The LAG and BAA agree to handle all work with extreme care, but will not be liable for theft or damage during the exhibit. If you wish to insure your work you must make your own arrangements. Submitting your work shall imply an agreement by the artist to the conditions set forth in the prospectus and permission to use your artwork for publicity.
